During the month of October 2016, the Net Asset Value (NAV) of the AKD Aggressive Income Fund appreciated by 0.54%, annualized return of 5.34%, underperforming the benchmark by 1.03%.

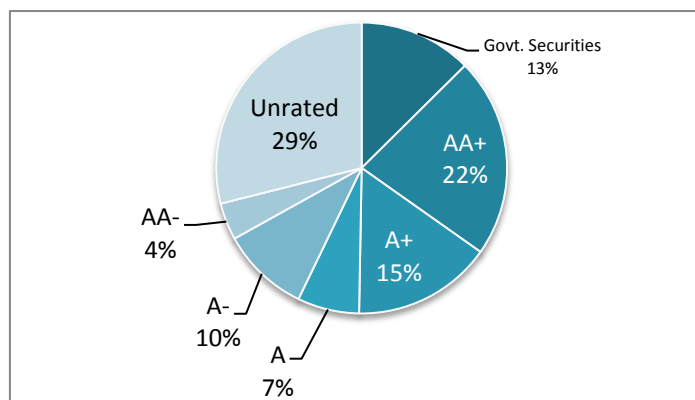
