Fund Manager's Comments

During the month of April 2014 the Net Asset Value (NAV) of the AKD Aggressive Income Fund (formerly AKD Income Fund) appreciated by 0.73% (annualized return 8.97%) underperforming the benchmark by 1.49% due to impairment on certain corporate debt securities. We continue to advise our investors to participate in the AKD Aggressive Income Fund due to expected reversals on the debt securities in the coming months.

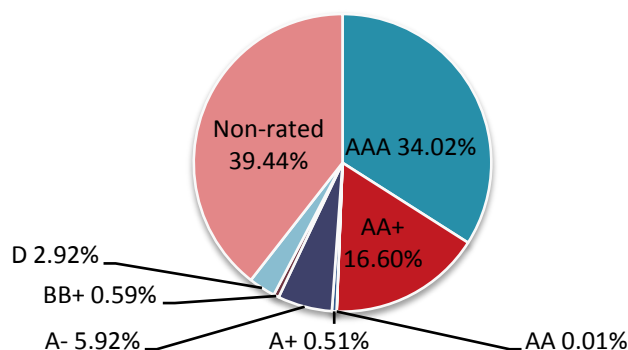
