During the month of August 2016, the Net Asset Value (NAV) of the AKD Aggressive Income Fund appreciated by 0.60%, annualized return of 6.62%, outperforming the benchmark by 0.29%.

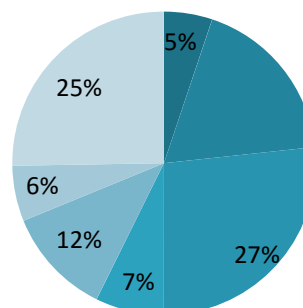
