Fund Manager's Comments

During the month of December 2016, the Net Asset Value (NAV) of the AKD Aggressive Income Fund appreciated by 0.4%, annualized return of 4.58%, underperforming the benchmark by 1.85% .

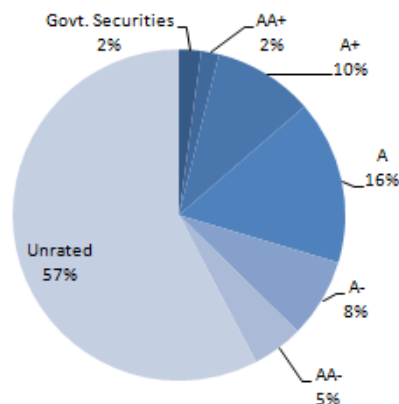
