During the month of July 2016, the Net Asset Value (NAV) of the AKD Aggressive Income Fund appreciated by 0.75% annualized return 9.49%, outperforming the benchmark by 3.18%.

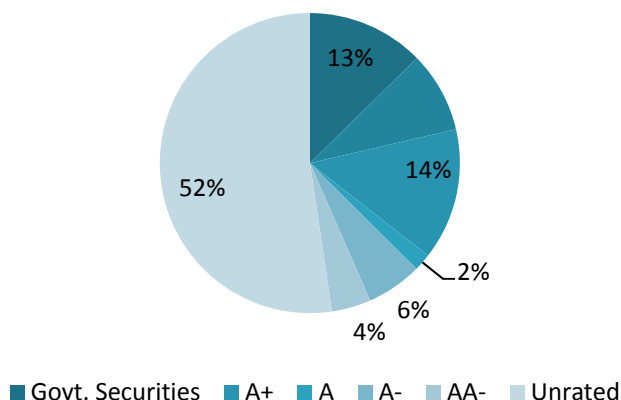
