During the month of March the Net Asset Value (NAV) of the AKD Aggressive Income Fund (formerly AKD Income Fund) appreciated by 0.80% (annualized return 10.13%). The fund outperformed the benchmark by 0.25% during the month of March primarily due to revaluation of corporate debt securities. We continue to advice our investors to participate in the AKD Aggressive Income Fund to reap gains from reversals on corporate debt paper and higher yields obtained by the fund from participating in the Margin Trading System.

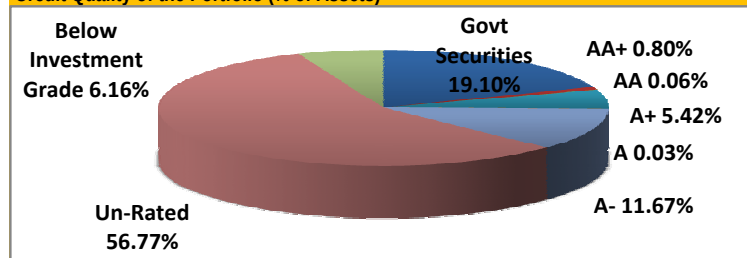
