During the month of March 2017, the Net Asset Value (NAV) of the AKD Aggressive Income Fund appreciated by 0.56%, annualized return of 6.59%, underperforming the benchmark by 0.18%.

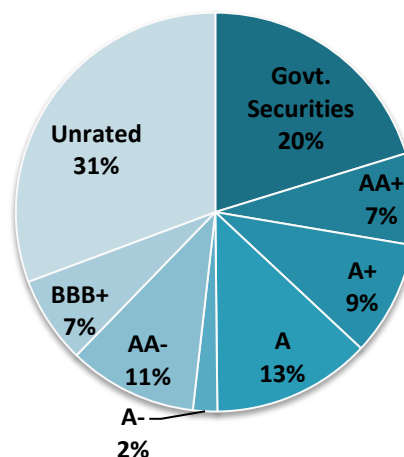
