For the month of October 2017 the FYTD return of the AKD Cash Fund stands at 4.59% versus the benchmark FYTD return which is 5.17%. Fund's return for the month stands at 4.32%.

The Fund will exclusively invest in highly secure ('AA' and above) short-term debt instruments such that the weighted average maturity of its net assets will stay below 90 days.

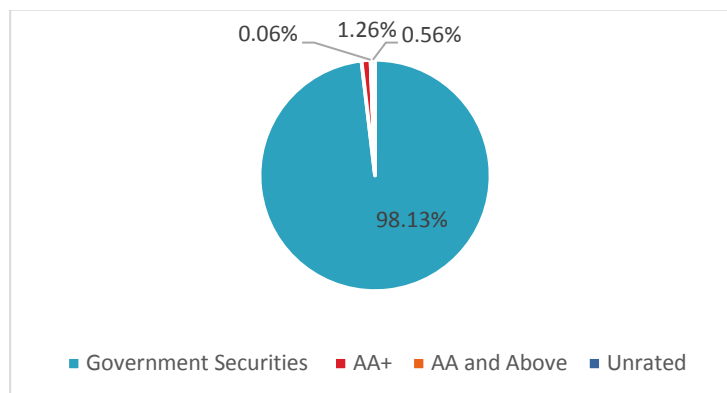
