For the month of September 2017 the FYTD return of the AKD Cash Fund stands at 4.66% versus the benchmark FYTD return which is 5.18%. Fund's return for the month stands at 4.55%.

The Fund will exclusively invest in highly secure ('AA' and above) short-term debt instruments such that the weighted average maturity of its net assets will stay below 90 days.

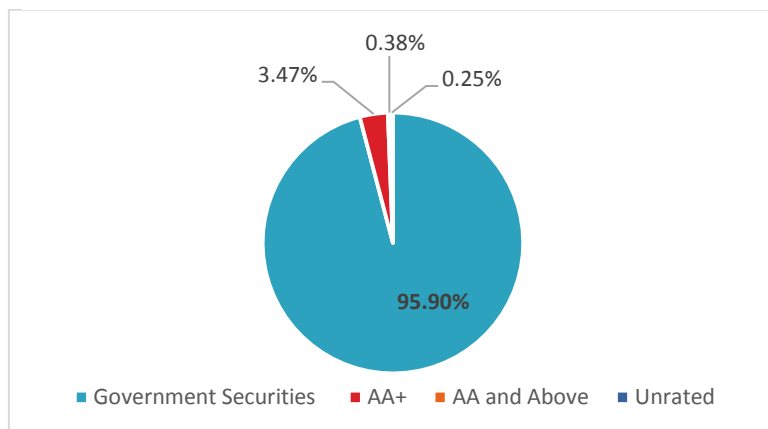
