For the month of September'18 the FYTD return of the AKD Cash Fund stands at 5.78% versus the benchmark FYTD return which is 6.59%. Fund's return for the month stands at 5.95%.

The Fund will exclusively invest in highly secure ('AA' and above) short-term debt instruments such that the weighted average maturity of its net assets will stay below 90 days.

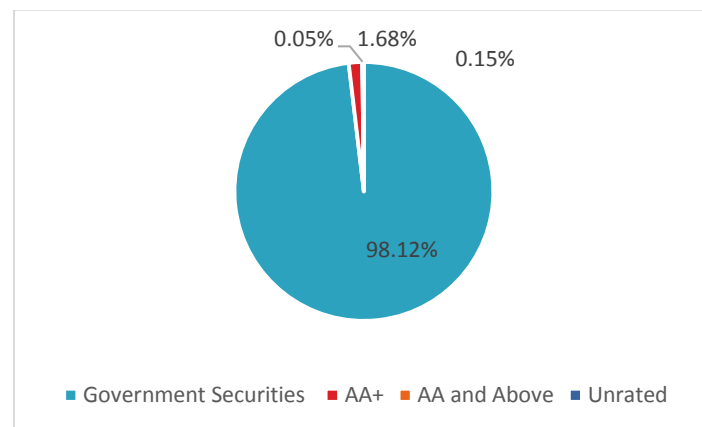
