During the month of February 2017, the Net Asset Value (NAV) of the AKD Aggressive Income Fund appreciated by 0.43%, annualized return of 5.58%, underperforming the benchmark by 0.83%.

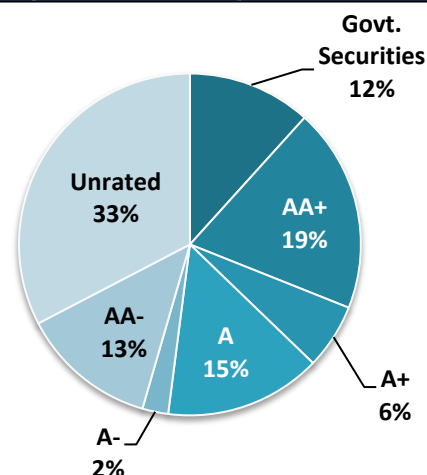
