Message from CIOs

The first month of CY22 ended on a positive note as the benchmark KSE-100 index surged by 778.61 points (up 1.75%MoM) to close at 45,374.68 points. Investor sentiments improved after the State Bank of Pakistan (SBP) maintained the policy rate at 9.75% with a view that current real interest rates are appropriate to guide inflation, support growth and maintain external stability. Moreover, Government successfully approved two bills from cabinet including Finance Supplementary Bill and SBP Amendment Bill paving the way for resumption of IMF program. The average daily traded volume also increased by 12.28% to 264.93 million as compared to 235.95 million recorded during the month of December 2021. Consecutively, KSE-100 index closed at a forward P/E and P/B of 5.20x and 0.8x respectively, with a healthy dividend yield of 8.6%.

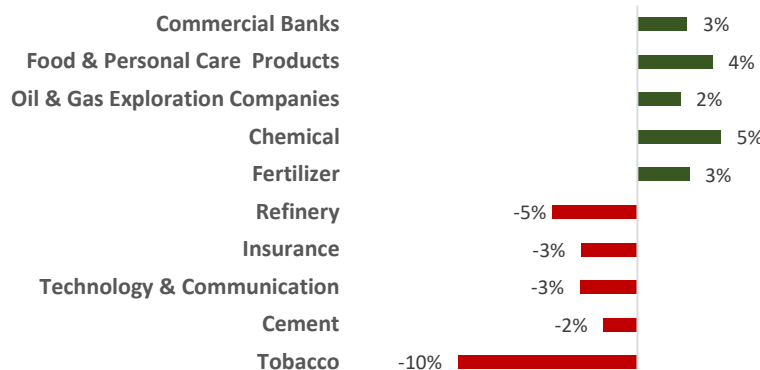
Foreign investors remained net buyers during the month, with a net inflow of USD 17.57 million as compared to inflows of USD 5.26 million recorded during the last month. This has taken cumulative outflows during FYTD22/CYTD22 to USD 232.78/17.57 million. On the other hand, Banks/DFIs and Companies remained net buyers with net inflows of USD 20.22 million and USD 5.14 million respectively whereas mutual funds and other organizations remained net sellers with net outflow of USD 22.35 million and 14.70 million respectively.

Major news that impacted the market during the month included: 1) the current account deficit expanded by \$1.93bn in December 2021 surpassing \$9bn mark in the first half of the ongoing fiscal year (5.7% of GDP), 2) The Senate approved the Finance Supplementary Bill, 2021 thus withdrawing tax exemptions worth PKR 343 billion, 3) The CPI clocked in at 21-month peak of 12.3% in December as prices of almost all commodities and utilities maintained a rising trend, 4) Pakistan foreign debt soared to USD 9.432 billion during 1HFY22 against the total budgeted external loans of USD 14.088 billion for FY22, 5) Global oil prices touched a high of USD 90 a barrel for the first time in seven years, 6) Inflows through Roshan Digital Account (RDA) reached USD 3.382 billion by end of January 2022 with 342,611 accounts.

CPI during the month of January 2022 surged by 13.0%YoY as compared to 12.3%YoY recorded during December 2021 taking 7MFY22 to 10.26%. Higher CPI was witnessed due to 13.77% YoY and 15.53% YoY increase in Non-Perishable Food Items along with Housing, Water and Energy prices respectively. Moreover, PKR appreciated by 1.0% during January 2021 to close at PKR 176.72 against USD.

On the Fixed Income front, yields of Government Securities flattened during the month as the SBP had given forward guidance in the last monetary policy statement of January 24, 2022 that further policy rate increases were not required. During the month, the SBP conducted two (2) MTB auctions with a cumulative realized amount of PKR 1.5 trillion. Weighted average yields for 3 months, 6 Months and 12 Months MTB decreased by ~18bps, 67bps and 57bps to 10.2030%, 10.6527% and 10.9068% respectively in the last auction.

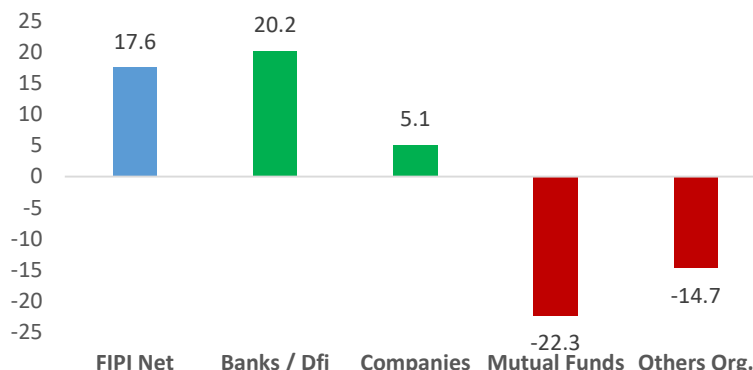
MARKET MOVERS



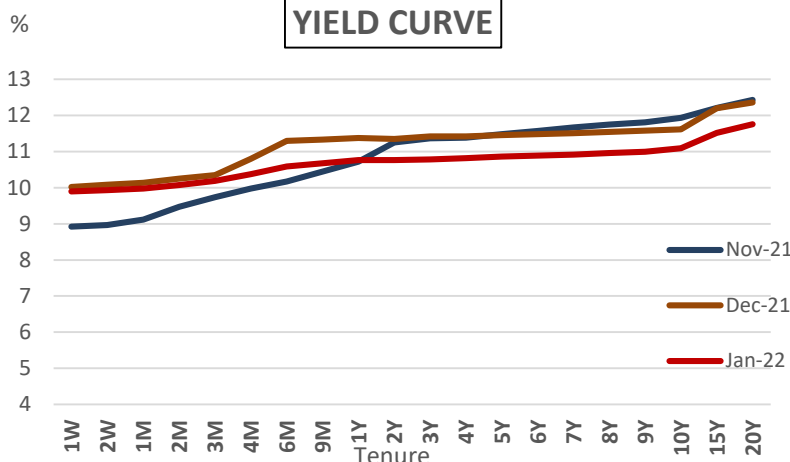

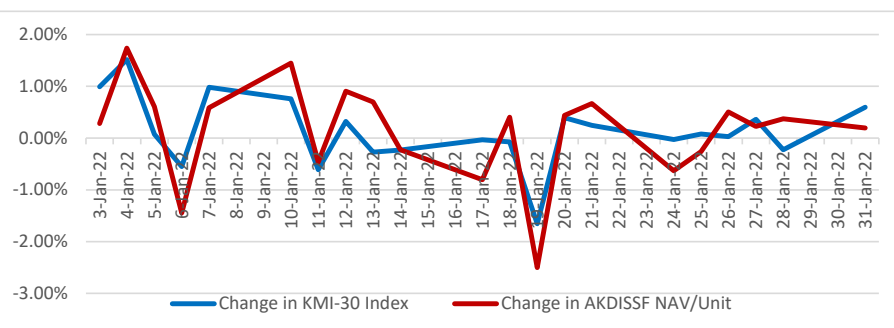

Disclosure of Sindh Workers' Welfare Fund (SWWF)

During the month of August 2021, provisioning against Sindh Workers Welfare Fund by AKDISSF amounting to PKR 2.26 million has been reversed on the basis of clarification received from Sindh Revenue Board vide letter No. SRB/TP/70/2013/8772 dated August 12, 2021 addressed to Mutual Funds Association of Pakistan, received on August 13, 2021. This reversal of provision has contributed towards an unusual increase in NAV of the AKDISSF (0.26/unit) 0.53%. This is one-off event and is not likely to be repeated in the future.
