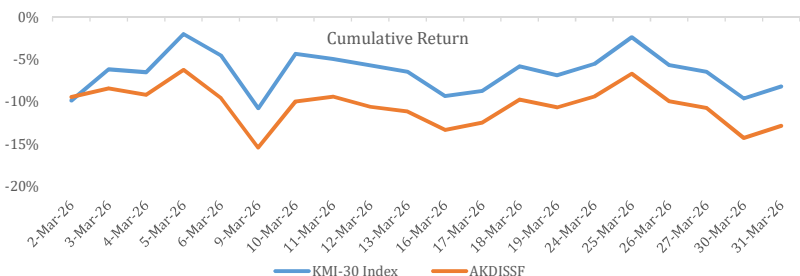


AKD Islamic Stock Fund
