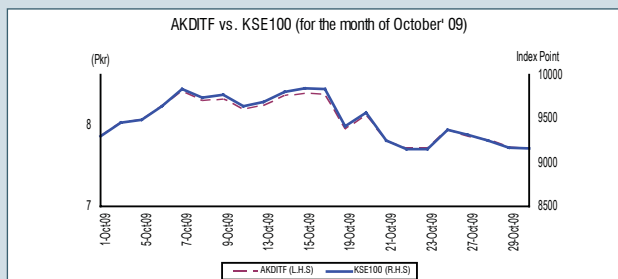

Fund activity during the month

The Index posted a negative return of 2.04%, where as the AKD Index Tracker Fund posted a negative return of 1.88%, thus, the fund outperformed its benchmark by 0.16%. The improving economic indicators, increase in liquidity in the system, and the increase in foreign investments reflect the beginning of a positive momentum in the market. During the month the overall tracking error was 0.16%, which is within the acceptable range as prescribed in the Offering Document of the fund.

To track the return of the KSE-100 index up to 85% accuracy, providing investors with a high quality, indepth diversification instrument.

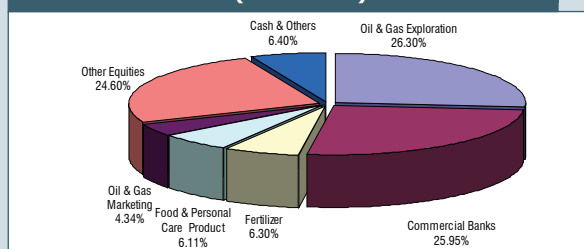
