For the month of Oct'15 the AKD Opportunity Fund (AKDOF) outperformed the benchmark KSE-100 Index. NAV of the AKD Opportunity Fund increased by 7.19% versus the benchmark KSE-100 Index that increased by 6.11%. Fiscal year to date return stood at 12.84% versus the benchmark KSE-100 Index return of (0.40%), outperforming the benchmark KSE-100 Index by 13.24%

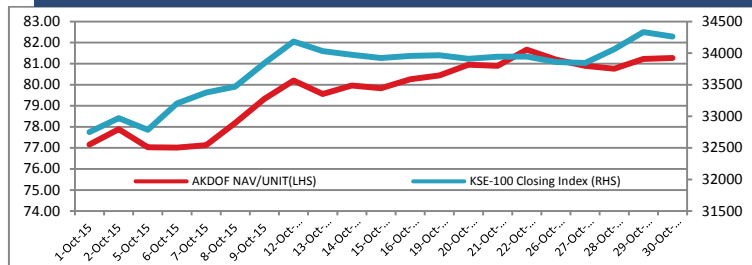
