For the month Dec'18 the AKD Opportunity Fund (AKDOF) outperformed the benchmark KSE-100 Index. The benchmark KSE-100 Index decreased by 8.47% versus the AKD Opportunity Fund that decreased by 7.33%. Fiscal year to date return stood at (10.22)% versus the benchmark KSE-100 Index return of (11.56)%.

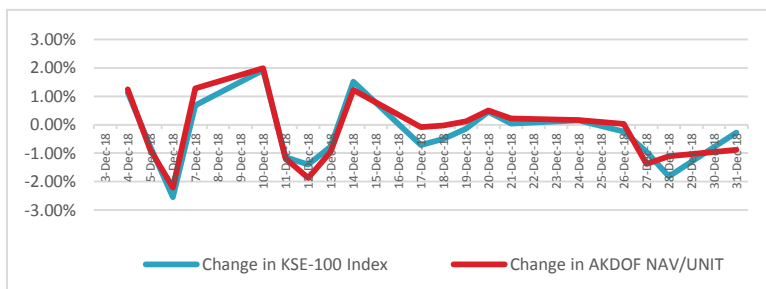
