Fund Manager's Comments

For the month of April'16 the AKD Opportunity Fund (AKDOF) outperformed the benchmark KSE-100 Index. The benchmark KSE-100 Index increased by 4.77% versus the AKD Opportunity Fund that increased by 9.69%. Fiscal year to date return stood at 10.82% versus the benchmark KSE-100 Index return of 0.93%, outperforming the benchmark KSE-100 Index by 9.89%.

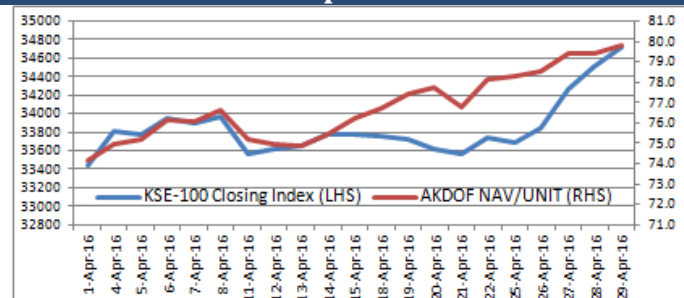
