Fund Manager's Comments

For the month of April'14 the AKD Opportunity Fund (AKDOF) underperformed the benchmark KSE-100 Index. NAV of the AKD Opportunity Fund increased by 3.66% versus the benchmark KSE-100 Index increase of 6.45%. Fiscal year to date return stood at 46.64% versus the benchmark KSE-100 Index return of 37.64%, outperforming the benchmark KSE-100 Index by 9%.

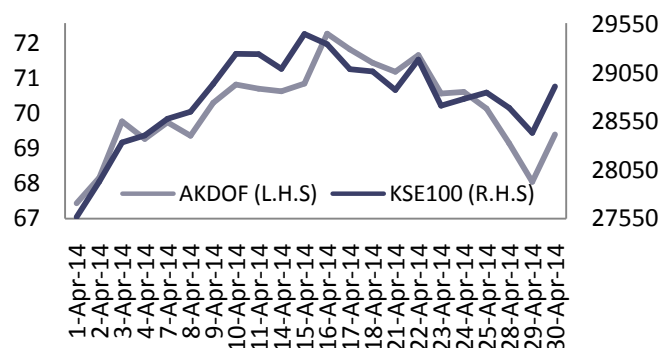
