For the month of April'19 the AKD Opportunity Fund (AKDOF) underperformed the benchmark KSE-100 Index. The benchmark KSE-100 Index decreased by 4.83% versus the AKD Opportunity Fund that decreased by 6.75%. Fiscal year to date return stood at (15.52)% versus the benchmark KSE-100 Index return of (12.23)%.

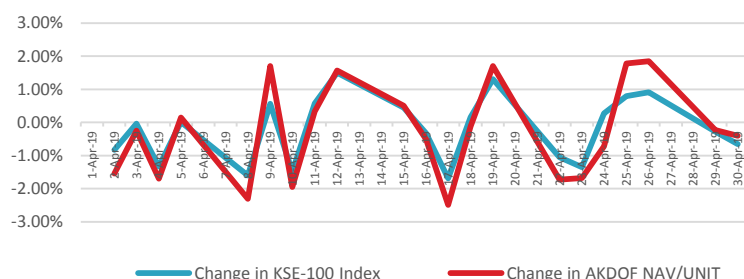
