Fund Manager's Comments

For the month of August'16 the AKD Opportunity Fund (AKDOF) outperformed the benchmark KSE-100 Index. The benchmark KSE-100 Index increased by 0.71% versus the AKD Opportunity Fund that increased by 9.33%. Fiscal year to date return stood at 15.34% versus the benchmark KSE-100 Index return of 5.36%, outperforming the benchmark KSE-100 Index by 9.98%.

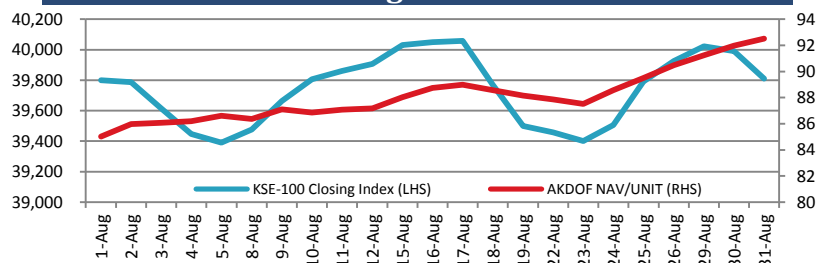
