Fund Manager's Comments

For the month Aug'18 the AKD Opportunity Fund (AKDOF) outperformed the benchmark KSE-100 Index. The benchmark KSE-100 Index decreased by 2.27% versus the AKD Opportunity Fund that decreased by 0.87%. Fiscal year to date return stood at (0.82) % versus the benchmark KSE-100 Index return of (0.40) %, thus unperformed the benchmark KSE-100 Index.

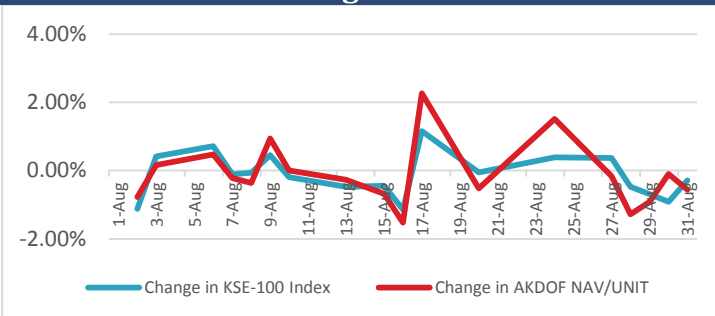
