Fund Manager's Comments

For the month of Dec'15 the AKD Opportunity Fund (AKDOF) outperformed the benchmark KSE-100 Index. NAV of the benchmark KSE-100 Index decreased by 1.00% versus the AKD Opportunity Fund that increased by 1.74%. Fiscal year to date return stood at 7.32% versus the benchmark KSE-100 Index return of (4.60%), outperforming the benchmark KSE-100 Index by 11.92%.

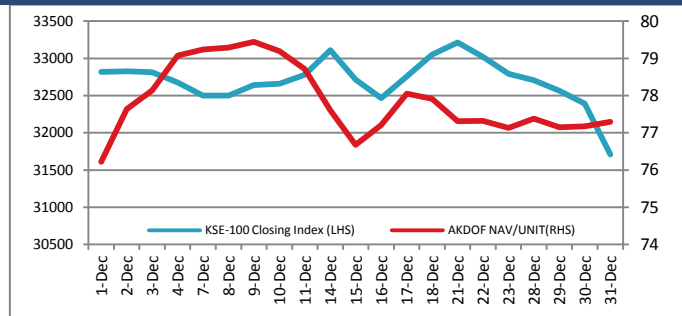
