Fund Manager's Comments

For the month of December'16 the AKD Opportunity Fund (AKDOF) underperformed the benchmark KSE-100 Index. The benchmark KSE-100 Index increased by 12.16% versus the AKD Opportunity Fund that increased by 5.90%. Fiscal year to date return stood 41.71% versus the benchmark KSE-100 Index return of 26.53%, outperforming the benchmark KSE-100 Index by 15.18%.

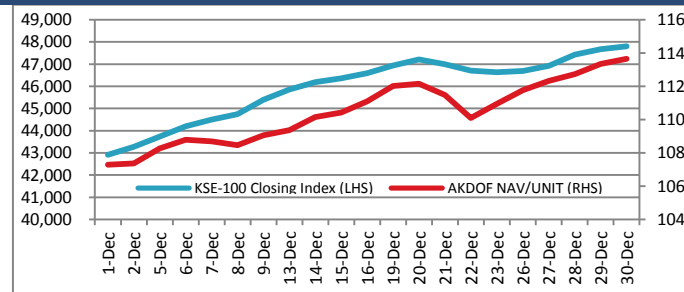
