For the month of December'17 the AKD Opportunity Fund (AKDOF) underperformed the benchmark KSE-100 Index. The benchmark KSE-100 Index increased by 1.15% versus the AKD Opportunity Fund that decreased by 2.26%. Fiscal year to date return stood at (14.98) % versus the benchmark KSE-100 Index return of (13.09) %, thus underperformed the benchmark KSE-100 Index by 1.89%

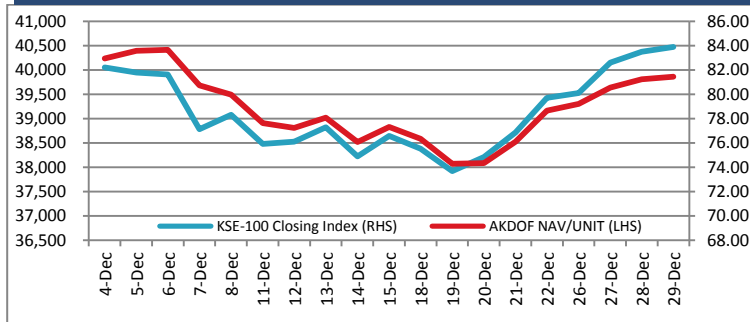
