For the month of January the AKD Opportunity Fund (AKDOF) has underperformed the benchmark KSE-100 Index.

NAV of the AKD Opportunity Fund increased by 1.73% versus the benchmark KSE-100 return of 2.00%. For the fiscal year the return of the AKD Opportunity Fund stood at 32.36% versus the benchmark KSE-100 return of 24.93%, thus significantly outperforming the benchmark by 7.43%.

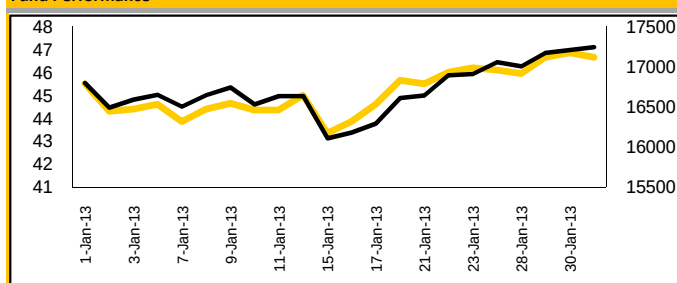
