For the month of July'17 the AKD Opportunity Fund (AKDOF) outperformed the benchmark KSE-100 Index. The benchmark KSE-100 Index decreased by (1.19%) versus the AKD Opportunity Fund that decreased by 0.06%. Fiscal year to date return stood at (0.06%) versus the benchmark KSE-100 Index return of (0.19%), outperforming the benchmark KSE-100 Index by 1.13%.

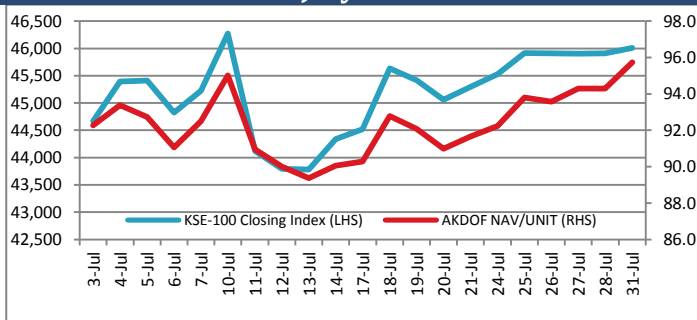
