For the month of July'15 the AKD Opportunity Fund (AKDOF) outperformed the benchmark KSE-100 Index. NAV of the AKD Opportunity Fund increased by 15.56% versus the benchmark KSE-100 Index that increased by 3.90%. Fiscal year to date return stood at 15.56% versus the benchmark KSE-100 Index return of 3.90%, outperforming the benchmark KSE-100 Index by 11.66%.

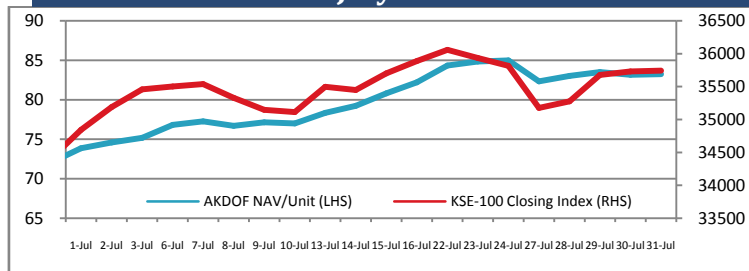
