Fund Manager's Comments

For the month of May'17 the AKD Opportunity Fund (AKDOF) underperformed the benchmark KSE-100 Index. The benchmark KSE-100 Index increased by 2.62% versus the AKD Opportunity Fund that increased by 2.51%. Fiscal year to date return stood at 52.74% versus the benchmark KSE-100 Index return of 33.90%, outperforming the benchmark KSE-100 Index by 18.84%.

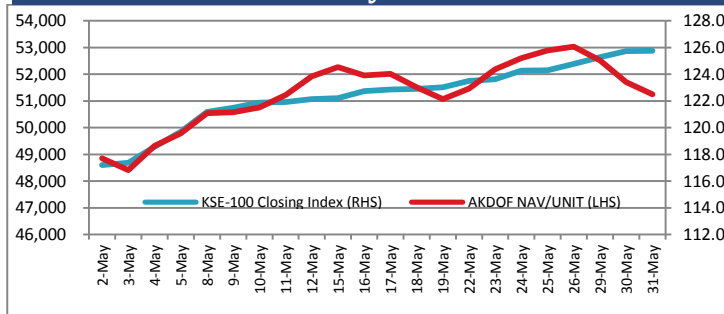
