Fund Manager's Comments

For the month of March '15 the AKD Opportunity Fund (AKDOF) underperformed the benchmark KSE-100 Index. NAV of the AKD Opportunity Fund decreased by -10.95% versus the benchmark KSE-100 Index decreased by -10.10%. Fiscal year to date return stood at 4.60% versus the benchmark KSE-100 Index return of 1.96%, outperforming the benchmark KSE-100 Index by 2.64%.

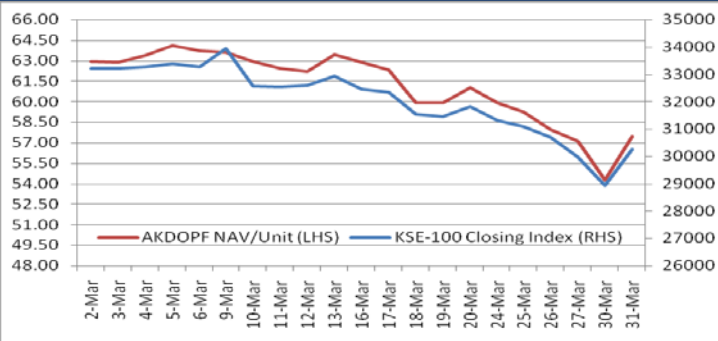
