Fund Manager's Comments

For the month of March'17 the AKD Opportunity Fund (AKDOF) outperformed the benchmark KSE-100 Index. The benchmark KSE-100 Index decreased by 0.78% versus the AKD Opportunity Fund that decreased by 0.65%. Fiscal year to date return stood at 46.59% versus the benchmark KSE-100 Index return of 27.45%, outperforming the benchmark KSE-100 Index by 19.14%.

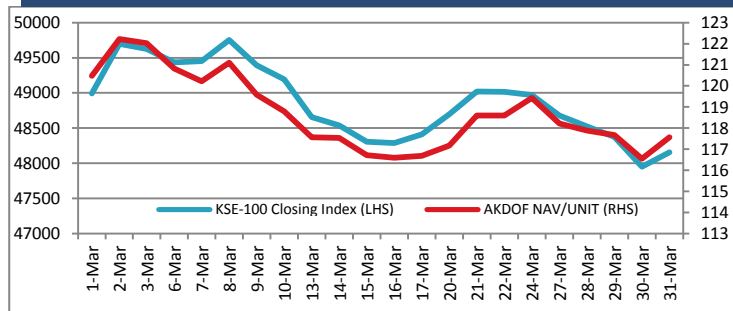
