For the month of May the NAV increased by 3.30% versus the benchmark KSE-100 of -1.46% thus significantly outperformed the benchmark KSE-100 Index by 4.76%.

The index is expected to remain firm for the coming months with room for profit taking from time to time. Investors are advised to be choosy with their stock selection as we have observed over the last four months, some stocks have moved up in multiples.

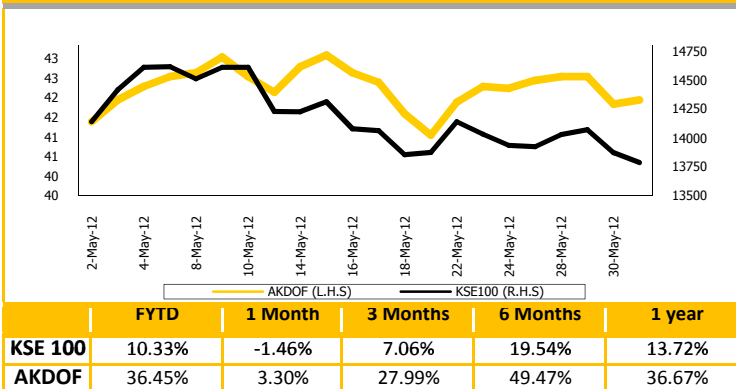
