For the month of May'19 the AKD Opportunity Fund (AKDOF) underperformed the benchmark KSE-100 Index. The benchmark KSE-100 Index decreased by 2.20% versus the AKD Opportunity Fund that decreased by 8.19%. Fiscal year to date return stood at (22.44) % versus the benchmark KSE-100 Index return of (14.16) %.

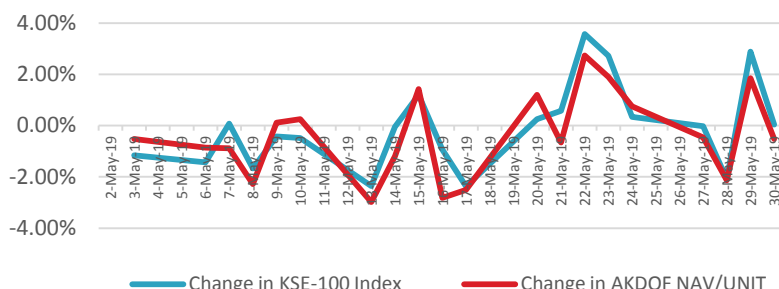
