Fund Manager's Comments

For the month of November'17 the AKD Opportunity Fund (AKDOF) outperformed the benchmark KSE-100 Index. The benchmark KSE-100 Index increased by 0.99% versus the AKD Opportunity Fund that increased by 3.79%. Fiscal year to date return stood at (13.02) % versus the benchmark KSE-100 Index return of (14.08) %, thus performed better then the benchmark KSE-100 Index by 1.06%
