For the month of October the AKD Opportunity Fund (AKDOF) has underperformed the benchmark KSE-100 Index.

NAV of the AKD Opportunity Fund increased by 0.32% versus the benchmark KSE-100 return of 3.01%. For the fiscal year the return of the AKD Opportunity Fund stood at 14.36% versus the benchmark KSE-100 return of 15.28, thus slightly underperforming the benchmark.

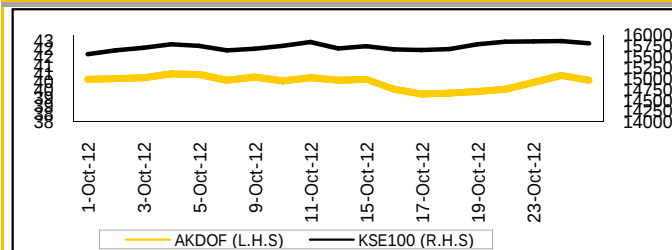
