Fund Manager's Comments

For the month of October'16 the AKD Opportunity Fund (AKDOF) Underperformed the benchmark KSE-100 Index. The benchmark KSE-100 Index decreased by 1.60% versus the AKD Opportunity Fund that decreased by 2.78%. Fiscal year to date return stood at 22.27% versus the benchmark KSE-100 Index return of 5.59%, outperforming the benchmark KSE-100 Index by 16.68%.

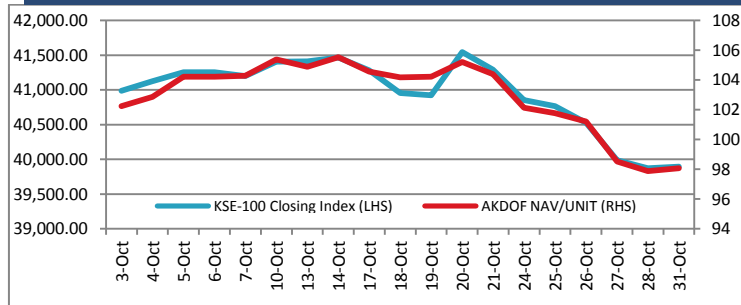
