Fund Manager's Comments

For the month Oct'18 the AKD Opportunity Fund (AKDOF) outperformed the benchmark KSE-100 Index. The benchmark KSE-100 Index increased by 1.59% versus the AKD Opportunity Fund that increased by 3.72%. Fiscal year to date return stood at (1.18)% versus the benchmark KSE-100 Index return of (0.62) %, thus unperformed the benchmark KSE-100 Index.

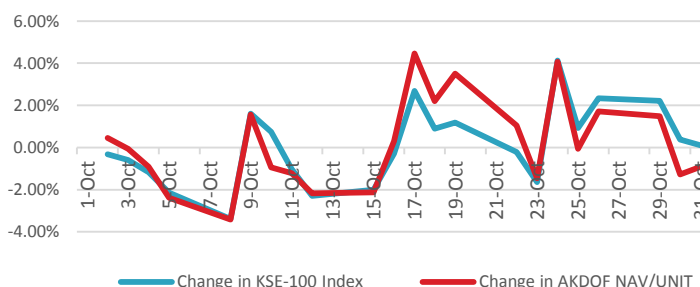
