For the month of September'19 the AKD Opportunity Fund (AKDOF) underperformed the benchmark KSE-100 Index. The benchmark KSE-100 Index increased by 8.11% versus the AKD Opportunity Fund that increased by 3.52%. Fiscal year to date return stood at -13.66% versus the benchmark KSE-100 Index return of -5.38%.

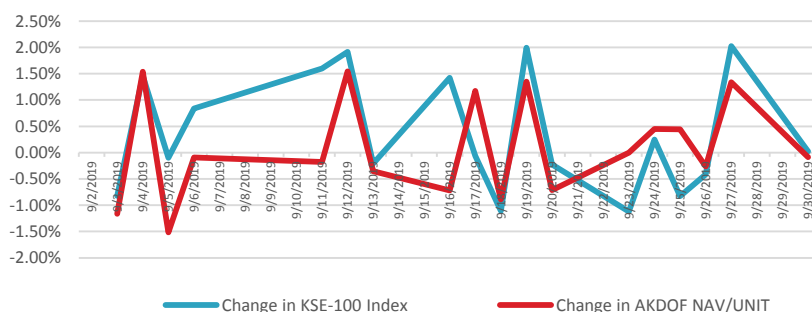
