Fund Manager's Comments

For the month Sept'18 the AKD Opportunity Fund (AKDOF) underperformed the benchmark KSE-100 Index. The benchmark KSE-100 Index decreased by 1.78% versus the AKD Opportunity Fund that decreased by 3.94%. Fiscal year to date return stood at (4.72) % versus the benchmark KSE-100 Index return of (2.18) %, thus underperformed the benchmark KSE-100 Index.

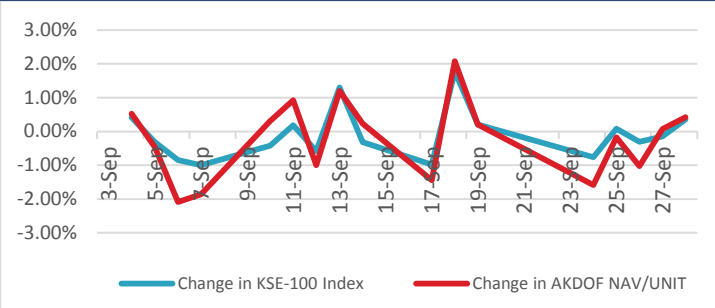
