Fund Manager's Comments

For the month June'18 the AKD Opportunity Fund (AKDOF) underperformed the benchmark KSE-100 Index. The benchmark KSE-100 Index decreased by 2.18% versus the AKD Opportunity Fund that decreased by 4.51%. Fiscal year to date return stood at (13.38) % versus the benchmark KSE-100 Index return of (9.99) %, thus slightly underperformed the benchmark KSE-100 Index.

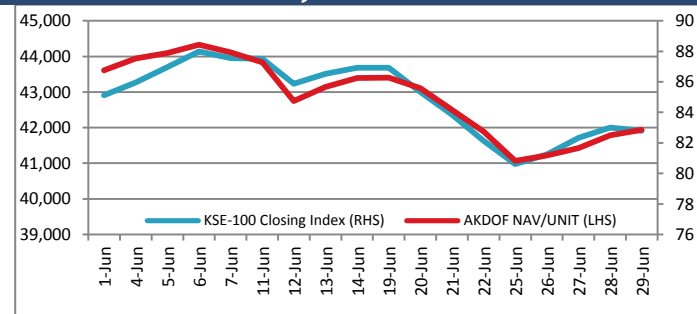
