For the month of April 2017, NAV of the Golden Arrow Selected Stocks Fund Ltd increased by 1.87% versus the benchmark KSE-100 Index which increased by 2.38%. The fiscal year to date return of the GASSFL stood at 57.42% versus the benchmark KSE-100 Index returns of 30.48%.

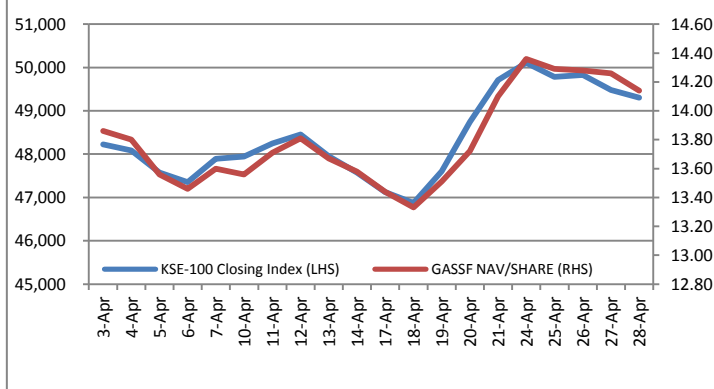
