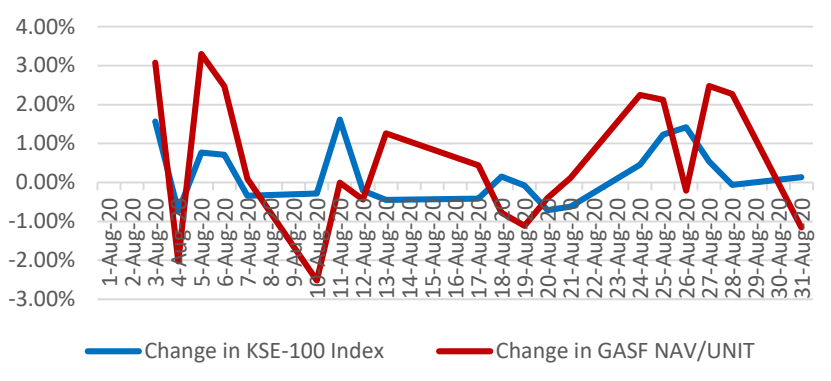
Details of Non-Compliant Investment
