For the month of June'20, NAV of the Golden Arrow Stock Fund Ltd increased by 0.82% versus the benchmark KSE-100 Index which increased by 1.45%. The fiscal year to date return of the GASF stood at -4.59% versus the benchmark KSE-100 Index return of 1.53%.

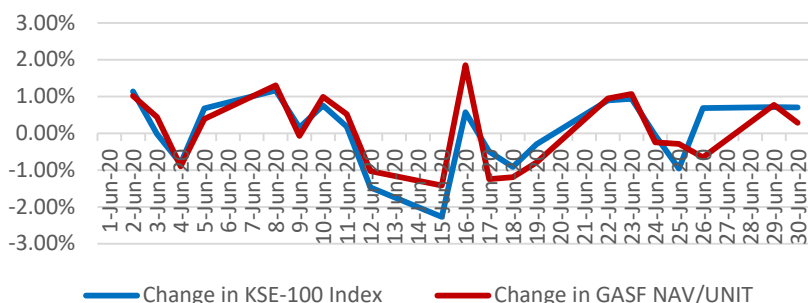
