Disclosure of Sindh Workers' Welfare Fund (SWWF):

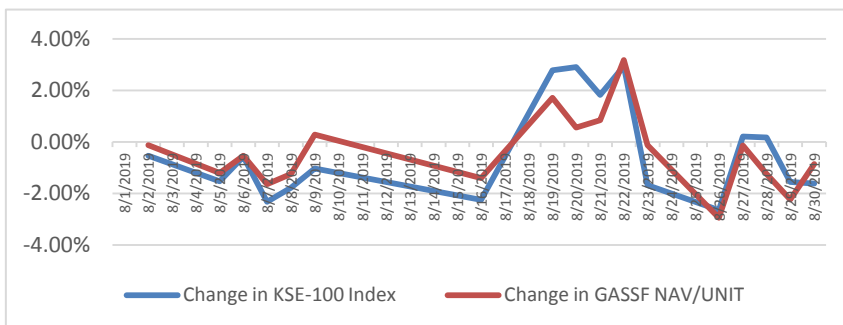
