For the month of December the Golden Arrow Selected Stocks Fund (GASSF) continued to outperform the benchmark KSE-100 Index.

NAV of the Golden Arrow Selected Stock Fund increased by 2.77% versus the benchmark KSE-100 return of 2.00%, outperforming the benchmark by 0.77%. For the fiscal year the return of the GASSF stood at 32.79% versus the benchmark KSE-100 return of 22.49%, thus significantly outperforming the benchmark by 10.3%

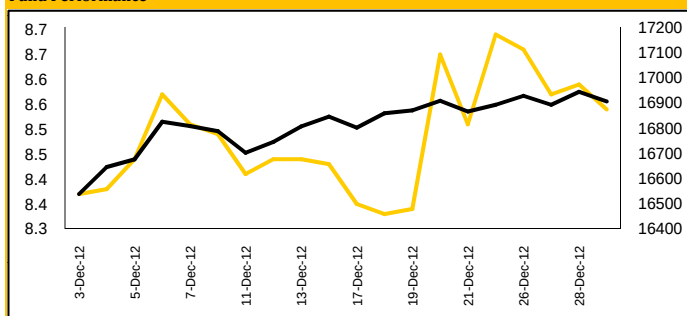
