Fund Manager's Comments

For the month of May 2015, NAV of the Golden Arrow Selected Stocks Fund Ltd increased by 0.43% versus the benchmark KSE-100 Index which decreased by 2%. The fiscal year to date return of the GASSFL stood at 14.68% versus the benchmark KSE-100 Index returns of 11.48%, thus outperforming the benchmark KSE-100 Index by 3.2%.

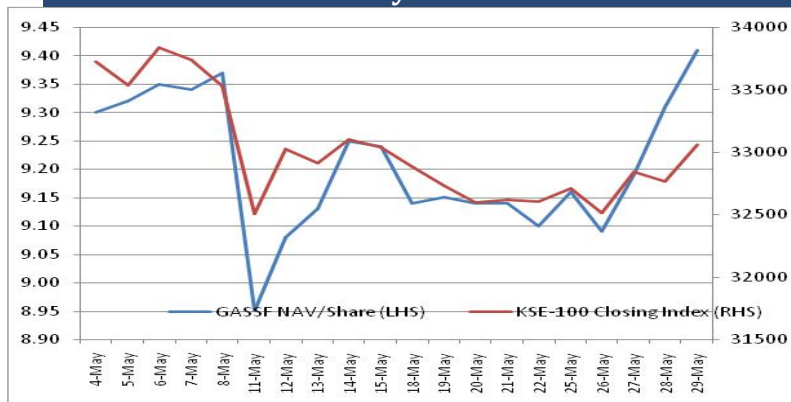
