For the month of October 2014, NAV of the Golden Arrow Selected Stocks Fund Ltd. has increased by 3.53% versus the increase in benchmark KSE-100 Index of 2.19%. For the fiscal year to date return of the GASSFL stood at 8.63 % versus the benchmark KSE-100 Index returns of 2.44%, thus outperforming the benchmark KSE-100 Index by 6.19%.

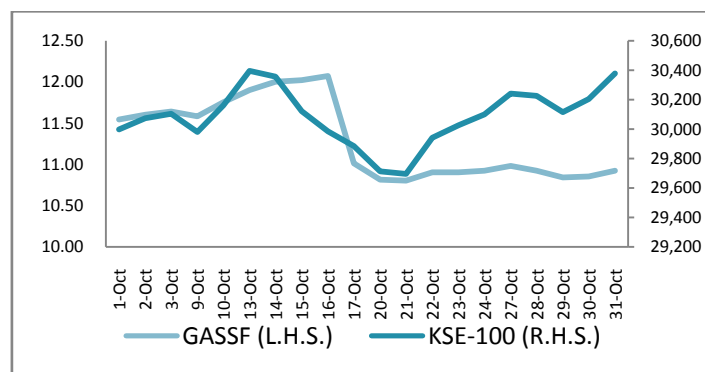
